On 3 February 2023, the Company as the borrower and certain financial institutions as lenders (the "**Lenders**") have entered into a facility agreement (the "**Facility Agreement**") for the granting by the Lenders to the Company of a 3-year term loan facility in an aggregate amount equal to HK\$970,000,000 (the "**Facility**").

As one of the conditions of the Facility, China Minmetals Corporation ("CMC", the ultimate controlling shareholder of the Company) shall, amongst other things, beneficially (directly or indirectly) own not less than fifty-one per cent. (51%) of the issued shares of the Company and have control over the Company. Upon a breach of any of the aforesaid conditions would constitute an event of default and Lenders may:

- (a) cancel all commitments under the Facility Agreement; and/or
- (b) demand that all or part of the loans, together with accrued interest, and all other amounts accrued under the Facility be immediately due and payable; and/or
- (c) demand that all or part of the loans under the Facility be payable on demand; and/or
- (d) exercise any or all of its rights, remedies, powers or discretions under the Facility Agreement.

As at the date of this announcement, CMC holds approximately 61.88% of the issued share capital of the Company.
