The Company announces that on 26 April 2010, SJQ, acting as contractor, and Jiahe Risheng, acting as the developer of LOHAS International Community in Changsha City, Hunan Province, the PRC, entered into the Construction Contract in respect of the supply and installation of aluminium doors and windows for certain part of Part II of Phase I of LOHAS International Community.

LOHAS International Community is a real estate development project in Changsha City, Hunan Province, the PRC. As at the date of this announcement, it is owned as to 51% by the Group and 49% by JS. JS is a wholly-owned subsidiary of Ershisanye which in turn is a non-wholly owned subsidiary of China Minmetals.
