

CONTINUING CONNECTED TRANSACTIONS

Property Management Service Contracts in respect of real estate development projects in Changsha and Wuhan

Reference is made to the announcement of the Company dated 22 December 2016 in relation to the 2017 Service Contracts entered into between each of Jiahe Risheng and Zhongrun Chengzhen (both being wholly-owned subsidiaries of the Company) with Minmetals Properties Hunan (a non-wholly owned subsidiary of China Minmetals) for the provision of property management services by Minmetals Properties Hunan to LOHAS International Community and Scotland Town respectively.

Each of Jiahe Risheng and Zhongrun Chengzhen has on 25 January 2019 entered into Service Contract I and Service Contract II with Minmetals Properties Hunan for the provision of property management services by Minmetals Properties Hunan to LOHAS International Community and Scotland Town respectively for a further term of 3 years from 1 January 2019 to 31 December 2021.

In addition, each of Hunan Kuangdai, Minmetals Land Wuhan and Wuhan Runling (all being wholly-owned subsidiaries of the Company) has on 25 January 2019 entered into Service Contract III, Service Contract IV and Service Contract V with Minmetals Properties Hunan for the provision of property management services by Minmetals Properties Hunan to Qin Royale, Enchanté Crest and Wuhan Scenery Cove respectively for a term of 3 years from 1 January 2019 to 31 December 2021.

Minmetals Properties Hunan is an indirect non-wholly owned subsidiary of China Minmetals which is the ultimate controlling shareholder of the Company indirectly interested in approximately 61.88% of the issued share capital of the Company as at the date of this announcement. Accordingly, Minmetals Properties Hunan is a connected person of the Company and the Transactions constitute continuing connected transactions for the Company under Chapter 14A of the Listing Rules.

As all of the applicable percentage ratios in respect of the Annual Cap Amounts under the 2019 Service Contracts are less than 5%, the Transactions constitute continuing connected transactions for the Company subject to announcement and reporting requirements but are exempt from the circular (including independent financial advice) and independent Shareholders' approval requirements under Chapter 14A of the Listing Rules.

BACKGROUND

Reference is made to the announcement of the Company dated 22 December 2016 in relation to the 2017 Service Contracts entered into between each of Jiahe Risheng and Zhongrun Chengzhen (both being wholly-owned subsidiaries of the Company) with Minmetals Properties Hunan (a non-wholly owned subsidiary of China Minmetals) for the provision of property management services by Minmetals Properties Hunan to LOHAS International Community and Scotland Town respectively.

Each of Jiahe Risheng and Zhongrun Chengzhen has on 25 January 2019 entered into Service Contract I and Service Contract II with Minmetals Properties Hunan for the provision of property management services by Minmetals Properties Hunan to LOHAS International Community and Scotland Town respectively for a further term of 3 years from 1 January 2019 to 31 December 2021.

In addition, each of Hunan Kuangdai, Minmetals Land Wuhan and Wuhan Runling (all being wholly-owned subsidiaries of the Company) has on 25 January 2019 entered into Service Contract III, Service Contract IV and Service Contract V with Minmetals Properties Hunan for the provision of property management services by Minmetals Properties Hunan to Qin Royale, Enchanté Crest and Wuhan Scenery Cove respectively for a term of 3 years from 1 January 2019 to 31 December 2021.

REASONS FOR AND BENEFITS OF ENTERING INTO THE 2019 SERVICE CONTRACTS

Minmetals Properties Hunan is classified as Class I property management corporation by the relevant government authority in the PRC and has obtained ISO 9001 and ISO 14001 certifications. Minmetals Properties Hunan has provided management services for high-rise residential units, villas, commercial and office buildings and clubhouses in various cities in the PRC.

Given the qualifications and experience of Minmetals Properties Hunan and the services provided by Minmetals Properties Hunan to LOHAS International Community and Scotland Town under the 2017 Service Contracts, the Company would like to continue to engage Minmetals Properties Hunan to provide property management services to the two projects upon expiration of the 2017 Service Contracts and for its other real estate development projects in the Central China area.

The Directors (including independent non-executive Directors) consider that the terms of the 2019 Service Contracts are fair and reasonable, on normal commercial terms, in the ordinary and usual course of business of the Group and in the interest of the Company and

the Shareholders as a whole. No Director has a material interest in the transactions contemplated under the 2019 Service Contracts nor is required to abstain from voting on the board resolutions approving the Transactions.

INFORMATION ON THE PARTIES

The Group is principally engaged in the businesses of real estate development, specialised construction, property investment and securities investment.

Jiahe Risheng is a wholly-owned subsidiary of the Company and is principally engaged in the development of LOHAS International Community in Changsha, Hunan Province, the PRC.

Zhongrun Chengzhen is a wholly-owned subsidiary of the Company and is principally engaged in the development of Scotland Town in Changsha, Hunan Province, the PRC.

Hunan Kuangdai is a wholly-owned subsidiary of the Company and is principally engaged in the development of Qin Royale in Changsha, Hunan Province, the PRC.

Minmetals Land Wuhan is a wholly-owned subsidiary of the Company and is principally engaged in the development of Enchanté Crest in Wuhan, Hubei Province, the PRC.

Wuhan Runling is a wholly-owned subsidiary of the Company and is principally engaged in the development of Wuhan Scenery Cove in Wuhan, Hubei Province, the PRC.

Minmetals Properties Hunan is an indirect non-wholly owned subsidiary of China Minmetals and is principally engaged in property management and consultation, property agency service, property leasing, cleaning service, and sale of hotel supplies, construction materials and daily supplies.

LISTING RULES IMPLICATIONS

Minmetals Properties Hunan is an indirect non-wholly owned subsidiary of China Minmetals which is the ultimate controlling shareholder of the Company indirectly interested in approximately 61.88% of the issued share capital of the Company as at the date of this announcement. Accordingly, Minmetals Properties Hunan is a connected person of the Company and the Transactions constitute continuing connected transactions for the Company under Chapter 14A of the Listing Rules.

As all of the applicable percentage ratios in respect of the Annual Cap Amounts under the 2019 Service Contracts are less than 5%, the Transactions constitute continuing connected transactions for the Company subject to announcement and reporting requirements but are exempt from the circular (including independent financial advice) and independent Shareholders' approval requirements under Chapter 14A of the Listing Rules.
