

PROPERTY SALES UPDATE FOR THE NINE MONTHS ENDED 30 SEPTEMBER 2021

This announcement is made by Minmetals Land Limited (the "Company") pursuant to the Inside Information Provisions (as defined under the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules")) under Part XIVA of the Securities and Futures Ordinance (Cap.571 of the Laws of Hong Kong) and Rule 13.09(2)(a) of the Listing Rules.

The Company announces that the contracted sales of the Company together with its subsidiaries, joint ventures and associates for the first nine months ended 30 September 2021 reached approximately RMB15.0 billion, with a year-on-year increase of 87.5%; and the contracted gross floor area ("GFA") sold was approximately 682,000 square meters, with a year-on-year increase of 84.8%.
