**DISCLOSURE PURSUANT TO RULE 13.18
OF THE LISTING RULES**

This announcement is made pursuant to Rule 13.18 of the Listing Rules in respect of a revolving loan facility in an aggregate amount of HK\$780,000,000 offered by the Bank and accepted by ONFEM Finance Limited (a wholly-owned subsidiary of the Company), the Company and Minmetals Land Investments Limited on 29 October 2021.

The Bank requires, among other things, a minimum shareholding maintained by the controlling shareholder of the Company for the aforesaid facility.

This announcement is made by Minmetals Land Limited (the “**Company**”) pursuant to Rule 13.18 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”).

On 29 October 2021, ONFEM Finance Limited (a wholly-owned subsidiary of the Company) as the borrower, and the Company together with Minmetals Land Investments Limited (a wholly-owned subsidiary of the Company) as the guarantors accepted the offer from a bank (the “**Bank**”) for the grant of a 364-days revolving loan facility in an aggregate amount of HK\$780,000,000 (the “**Facility**”).

As one of the conditions of the Facility, China Minmetals Corporation (“**CMC**”, the ultimate controlling shareholder of the Company) shall beneficially own (directly or indirectly) at least 31% interest of and has management control over the Company. Upon a breach of any of the aforesaid conditions, the Facility is repayable in full amount on demand by the Bank.

As at the date of this announcement, CMC holds approximately 61.88% of the issued share capital of the Company.

The Company will make continuing disclosure pursuant to Rule 13.21 of the Listing Rules.
